SELECTION PROCESS		

- ▶ KOI will conduct a merit-based review of each application. With the recommendation of a Selection Committee comprising of the admission manager, student services manager and VP Academic, KISS will be awarded to eligible students who have demonstrated academic excellence in their previous studies.
- ▶ The decision of the KOI Committee will be final. The processing time is between 2-4 working days.

## \*ONGOING CONDITIONS / REQUIREMENTS

- ▶ Students must maintain a 100% pass record for the scholarship to remain active.
- ▶ The scholarship is not transferable.
- ▶ Students must pay the required tuition fees by relevant due dates.
- ▶ The scholarship remains valid for students on an approved Leave of Absence for one trimester only.
- ▶ Scholarship applications will not be considered after the intake Census Date.
- ▶ Successful applicants must also agree to act as a student ambassador for the KOI Society and support promotional activities.

However, below you will find a general guide on the type of advice you will be given depending on which requirements you do not meet.

### When you do not have the minimum English level

Please contact KOI's Admissions and Marketing departments via the email addresses provided above for guidance on meeting KOI's English entry requirements. Usually you will be advised to undertake an English Language Intensive Course for Overseas Students (ELICOS) and/or English for Academic Purposes (EAP) studies with one of our Direct Entry Partners. Please keep in mind that KOI does not arrange ELICOS or EAP studies on the behalf of students or agencies and thus these studies must be arranged independently.

### When you do not meet minimum academic qualifications

Applicants frequently find that they do not meet the minimum academic qualifications required for KOI's postgraduate programs. Unfortunately, no alternative studies will satisfy these requirements, except for obtaining an Australian three-year Bachelor's degree, which would enable you to meet the entry criteria for postgraduate study.

In such instances, KOI Admissions or KOI Marketing will advise pursuing an undergraduate program at KOI initially. If you have completed relevant studies overseas, you may also be eligible for credit towards your undergraduate studies should you choose this pathway.

## FEE-HELP

### WHAT IS FEE- HELP?

- FEE-HELP is a loan scheme that helps eligible students enrolled in a fee paying place to pay their tuition fees.

Fee paying places are generally available for postgraduate courses at universities, and in both undergraduate and postgraduate courses offered by private providers.

- You do not have to use a FEE-HELP loan to pay your tuition fees. You can choose to pay all your tuition fees upfront, or you can pay some upfront and use a FEE-HELP loan for the rest, or use a FEE-HELP loan for all your tuition fees (up to your FEE-HELP limit).

To get a FEE-HELP loan, you must

- be an Australian citizen and study at least part of your course in Australia.
- be a New Zealand Special Category visa (SCV) holder or permanent humanitarian visa holder and meet the residency requirements. (Permanent residents can only get FEE-HELP for approved bridging studies.)
- be enrolled in a fee-paying place at a provider that offers FEE-HELP loans.
- be enrolled in an eligible course at your provider by the census date.
- submit the Request for FEE-HELP form to your provider by the census date.
- not have already borrowed up to your FEE-HELP limit. (\$126,839 in 2025)

If you are studying at a non-university, you will also need to meet the 'pass rate' requirements.




